Alumni Profile Steve Stratton '71 'The Fraternity Was an Anchor'

Three years from now, the Chicago skyline is going to change as a new 60-story office tower rises on the Chicago River. Nearly half of the planned 1.3-million square feet of the tower has already been leased by Kirkland & Ellis, an international law firm, making this one of the single largest real estate deals in the history of Chicago. And it was an Alpha Tau Omega brother from the University of Illinois who made it happen.

Steve Stratton '71 is the regional president of The Staubach Company's Midwest corporate sales division, based in Chicago. The Staubach Company is a leading global real estate advisory firm, finding office solutions for large organizations. We experimented and partied and grew our hair long, only to go back to the real world upon graduation," he recalls with a smile. "The fraternity served as an anchor: It exposed us to a broad array of life, taught us to rely on people from different walks of life and helped us keep things in perspective."

Later, he says, the fraternity served both as a support system and a network, introducing him to friends of friends, many connected through the fraternity.

Some of Steve's favorite memories of his fraternity days are of "the more intense hazing rituals," adding that recalling those times always brings a good laugh. "Those rituals brought all of us together. They set the bar higher, and gave us a different perspective on everything and the desire to meet difficult tasks. The world today doesn't set the bar high enough."

He notes that his pledge class held a 25thanniversary reunion in 1996, which sparked a renewed interest in keeping in touch. "We've been reconnecting in the years since then."

Steve and his wife Sarah celebrated their 25th wedding anniversary this summer. They live in Chicago, III., with their three children, ages 15, 13 and 10. Steve says he now finds himself living vicariously through his kids, but his own life seems busy enough.

When asked about his goals for the future, Steve lists four: to remain healthy, continue to see his family grow and prosper, perpetuate The Staubach Company in the Midwest, and keep snow skiing and playing golf. This sounds like a man who's found balance and happiness. We wish him continued success.
