# **CHAPTER HOUSE IMPROVEMENTS**

## Gamma Zeta Undergoes Makeover to Remain Competitive with Alternative Housing Options on Campus

It is imperative that we remain competitive with alternative housing options on campus, and therefore we must strive to provide optimal living conditions for our members. Doing so requires us combating the inevitable aging and abuse of the Chapter House. As such, House

Corporation has fully drawn on its \$300,000 financing line secured two summers ago to complete much needed aesthetic and safety enhancements over the past two summer breaks. Improvements have included the



installation of a fire suppression sprinkler system (as mandated by local and National Fraternity guidelines), the refurbishment of exterior French doors (living room wings and dining room), the refinishing of the living room walls and floors, installation of a new staircase banister from the living room to living quarters, gut-rehab of the ladies bathroom and about \$27,000 worth of new furniture. Future improvements call for the conversion of the bike room to a new TV/recreation room,

refurbishment of the dining room and the installation of a rooftop deck that overlooks the basketball court. These improvements are made possible by the generous giving of thousands of alumni – thank you!

"I'm sure no one ever had as much gratitude for any group as I have had for over 65 years for my Cham-Bana Taus, who saved my carcass from eradication from U of I in the fall of 1942. I got great food at the frat house, loved playing on our soccer team, loved the band and the ROTC (horse cavalry), but the University stuck me with 20 1/2 credit hours, advanced chem. and math. Freshmen had no advisors, so I could not talk to professors or have teaching assistance. I had a great visit at our chapter house six weeks ago, the first in 65 years. I was gone 3 years in the Army Air Forces during WW II; then I entered college at Univ. of Tulsa, where I was stationed as an aviation student for 3 months before entering the Aviation Cadet program. After WW II was over, I enrolled in Engineering Physics and was very active in a local fraternity that ATO took over and was Pledge Master for 1 1/2 years, then WC and acting WM my last semester there. I loved it all."

## LeaderShape: ATO's CATALYST Program Allows Brothers to Explore Personal Integrity and Ability to Lead

### Chapter Maintains 100% Capacity for Sixth Consecutive Semester

At the time of our last newsletter, the Chapter's new leadership had recently been elected. President **Andrew Grosdidier**, Treasurer **Kevin Ellsworth**, Vice President **Matt Dixon** and Head House Manager **Dan Soso**, assumed their officer positions at the start of the 2008 Fall Semester with an eye towards working diligently to advance the fundamental living conditions at the house and to improve the fraternal bonds and level of respect among undergraduate members. This group set out on achieving the

following goals for the past academic year:

- i) achieve financial collections of 95% or better,
- ii) maintain a minimum of 75 live-in members,
- iii) achieve a top 10 academic ranking among fraternities, and
- iv) launch the University's only marquee campus-wide philanthropy event.

Despite falling short of these mandates while having to deal with a few "bad apples" along the way, this team exerted a tremendous amount of energy, time and integrity in executing their roles. This group has served the Fraternity well and we wish them the best.

The new leadership team is set to use the summer months to devise a strategy for the coming school year regarding effective transitioning of roles and responsibilities and goal setting.

For the sixth consecutive semester, the chapter house has reached capacity regarding the number of members living in-house. Maintaining this 100% capacity level will be essential to securing our financial flexibility in the coming years. On the other hand, the chapter house takes its fair share of abuse when operating at capacity. House Corporation has devoted many hours to restoring and renovating the chapter house so that it maintains its rich look and feel, but also ensuring that it meets the needs and enhances the fraternal living experience for each of our members.

Financially, the Chapter could be in

better condition. Collections this past year were not as strong as we'd typically like so House Corporation and the undergraduates are working to rectify those issues. House maintenance expenses continue to be higher than usual due primarily to increased house destruction activity from the few "bad apples" mentioned above.

Academically, the Chapter's performance has tumbled. Following the spring semester, the Chapter ranked #33 out of 48, with an overall Chapter GPA of 3.05. This mark was below the Interfraternity Council GPA of 3.12 and the All Fraternity GPA of 3.11. Improving the Chapter's overall house GPA is the undergraduate's top priority for the coming school year.

The House Corporation and the new undergraduate leadership team are taking necessary steps to cull recent destructive behavior and to improve its members' attitudes and perspectives. Rather than hosting a normal retreat, House Corporation thought it might be more beneficial to bring in an independent moderator to help assess the situation. On March 15, 2009, Gamma Zeta hosted a new LeaderShape workshop, called the CATALYST Program, designed to deal with Chapter specific issues and concerns while also providing individuals a chance to explore their own personal integrity and capacity to lead. All freshman, sophomore,

and junior members were required to attend. The day-long session, facilitated by Howe Wallace, National Alpha Tau Omega Board member, was well received. House Corporation is optimistic that positive interferences like CATALYST and ongoing transparent communication regarding expectations and proper management will improve the Chapter's outlook.

The philanthropy committee continues to struggle with getting a marquee philanthropy event up and running - we are targeting spring semester 2010 to have something in the works. In the meantime, the undergraduate members continue to proactively contribute to the community by raising money and volunteering service hours via a number of causes. First off I would like to highlight the success of this year's Mother's Day Annual Charity Auction. Gamma Zeta raised \$8,500 to benefit three unique and deserving charitable organizations: Children's Memorial Hospital in Chicago, Guatemala House and the Linda Mills Breast Cancer Foundation.

In other news, Gamma Zeta intends to carry on the tradition of its annual blood drive as well as encourage further community involvement via the Champaign-Urbana Park district as volunteer coaches, tutoring at Champaign middle schools and participating in other Greek philanthropy events. The completion of pledgeship now also requires a minimum of ten hours of community service.

### **Chapter Runs Successful Philanthropy Events and Focuses on Upcoming Rush**
